# **Hardwick Green Meadows Archives**

These are notes result from a trawl of the National Archives online catalogue, and the Eldersfield and Coventry records at the Worcestershire Archive and Archaeology collection at the Hive in Worcester. They are not comprehensive since they focus on the Hardwick Green area and the Marsh in order to provide a background to the Worcestershire Wildlife Trust's reserve there, but they may offer researchers a shortcut to other areas of interest locally. They were compiled in 2019.

# The Hive – Stroller

Eldersfield manor noted in Worcestershire for more than 1000 yrs. 4387 acres 2/3 permanent pasture 10 acres of woodlands (at one time very extensive). Loam and clay on Keuper Marl. Large portion marsh land until drainage of Longdon Marsh. Also, formerly included in Malvern Chace (sic). Eldersfield Court – the old manor house. Pigeon House Farm – traces of an ancient moat & 2 sundials one dated 1705. Lucas Moat Farm, traces of a moat, also at Hardwick Court. Large & very old ash in the churchyard believed to date from when parish was part of Malvern Forest. Earliest mention in possession of Pershore, perhaps given by King Edgar. Conquest seized by William Fitz-Osbern. Remained in hands of the King from Domesday to Henry I who bestowed it on his natural son Robert Earl of Gloucester sometimes called FitzRoy, decendants are Clares Despensers & Beauchamps.

Berkeleys principal mesne – lords in medieval times. Branch of the De La Mares in 12<sup>th</sup> c settled in Hardwicke, gift of William, 2<sup>nd</sup> Earl on Gloucester. Thomas De la Mare is found at Hardwicke about 1182 and a continuous series of his successors are traced to the 17<sup>th</sup> century. In the 7<sup>th</sup> year of Henry VI John De la Mare attended coronation in Paris and was made esquire. The church has a memorial to Richard De la Mare dated 1612. De la Mares continued for some 450 years but after the death of Richard De la Mare it was sold to Sir Thomas Coventry who was then engaged in forming the Croome estate. Hardwicke Court seat of De la Mares, Marsh Court formerly Marsh Place was a dependent Manor – De Marisco held under Eldersfield in the 15<sup>th</sup> C by the Winslows.

Sir Thomas Coventry bought Eldersfield manor after 1612 still Coventry in 1843 & 1865, and transferred to Croome Estate Trust in 1921 based now at High Green Estate office – George William Coventry 1838 – 1930.

1772 William Jeffs of Corse left the Cottage to his wife Ann for life, his son William was living there (in occupation of Richard Williams), the to his grandson Thomas Jeffes.

Thomas Jeffes died intestate leaving 2 daughters Louisa and Emma in Feb 1810. William Jeffes will of 1777 to son William - not at Lime Street and may be a jointure from his wife, and at his death to his son William. Also had sons Thomas and Benjamin. Lime St. as above and another message to grandson William. Grand-children Ann Halsey, John Jeffes, Benjamin Jeffes.

# Graveyard

William Davis of Cromer Farm died 25<sup>th</sup> April 1812 aged 79. Mary wife of Thomas Clarke of Dunshill died Oct 6<sup>th</sup> 1782 (?) aged 8? and Mary died aged 3.
