As I write the 2020/21 review, the Covid-19 vaccination programme continues apace, giving us hope

of a return to normality very soon. Covid-19 has had a great impact on the Trust this past year, as with the whole country. Our staff have had to work remotely for much of the year, there have only been a handful of school visits, no fundraising events and our volunteers stood down.

We have had to be creative in how to keep vital work going during this time – utilising digital engagement and management of contractors for essential work, becoming experts in the use of Zoom!

We are particularly grateful for how our 23,000+ members have stuck with us throughout the year, even though they have also faced uncertainty with health and financial concerns. They have supported our campaign to raise funds for our Saving Worcestershire's Heathlands appeal to buy land at Dropping Well Farm near Kidderminster. With further support from trusts and

foundations, and the National Lottery Heritage Fund, the purchase should be finalised this summer.

Due to the reduction in many revenue streams, the Trust has been financially conservative in ensuring tight control over expenditure. Through this management and securing the National Lottery Heritage Fund Emergency Fund funding, we have been able to re-open and recover many areas affected by the pandemic. An example of this is the new cuckoo hide that we have installed at Upton Warren. We are also pleased to have been able to maintain our trainee scheme, enabling our four trainees to run small projects and learn vital new skills for a career in nature conservation.

One positive from the pandemic restrictions on face-to-face contact has been an 83 per cent increase in social media engagement and we hope to continue growth in all areas of digital engagement.

Within Worcestershire the Trust now owns or manages over 3,000 acres of land, an area larger than the footprint of the Malvern Hills. We

advise other land managers who are responsible for 100,000 acres, around a quarter of the county. We continue to be driven to improve nature locally whilst contributing to the national objective of restoring 30 per cent of land for nature by 2030.

Of course, none of this would be possible without the continuing support of you, our members, our staff and trustees and the incredible work done by our volunteers. We are thankful to our funders, particularly the National Lottery Heritage Fund, Severn Waste Services, The Banister Charitable Trust, The Esmée Fairbairn Foundation and The Rowlands Trust for their continued support. We would also like to thank those who left a gift in their will to the Trust, or donated in memory of loved ones, during the year.

On behalf of all Trustees, we say a big thank you to everyone for your continued support to enable us to look forward with confidence to continuing the Trust's vital work.

## Financial performance


A surplus of £1,008,658 was recorded in the year after gains and losses. There was an unrealised gain on investments for the year of £519,239, which accounts for the majority of the surplus. Net assets stand at £16,687,198 of which £12,159,470 represents the value of our nature reserves and other fixed assets, and £3,607,367 the value of our investments. At 31 March 2021, £4,051,456 was designated for use in conservation and development projects.


## Worcestershire Wildlife Trust's income in 2020–21
